## AC-3010 Gel-type Cleaner and Degreaser

**AC-3010** is a liquid, viscous, non-petroleum, solventbased cleaner for use on both painted and unpainted surfaces. Designed for application on vertical surfaces and large structures.

- Powerful cleaning action on grease and oil based contaminants.
- Safe on aluminum, cadmium, cad plate, and other structural metals.
- Will not cause hydrogen embrittlement in high-strength steel.
- Nonflammable.
- Safe on most plastics.

**AC-3010** is designed for ready to use application. Ideal for large equipment or difficult-to-reach areas where increased contact and dwell time may be substituted for scrubbing.

Apply **AC-3010** undiluted with mop, brush, or spray. Allow to remain on surface for up to 30 minutes depending on temperature (warmer temperatures may reduce dwell time). Agitate the surface with a brush, spray, or some other means of agitation wherever possible. Rinse with a pressure stream of water.

A one-to-one dilution with water has been found to be effective for greasy areas where agitation can be applied.

Dilution of 1 part **AC-3010** with 4 parts water is recommended for routine use.

A solution of 1 part **AC-3010** in 9 parts water may be used for light-duty general cleaning.

**Caution**: Avoid contact with skin and eyes. Use rubber clothing and face shield. Use with adequate ventilation. In case of accidental contact with eyes, flush with plenty of water, and contact physician.
